Housing Update 2022

Tuesday 10 May (venue tbc)

This event will consider how planners can help to deliver the right homes in the right places, meeting the needs of local communities, supporting local priorities and creating sustainable and beautiful places.

Public Inquiries

Monday 13 June - Pinsent

Masons, Manchester

This event will consider Inquiry procedures with an emphasis on the approach to giving witness evidence. The event aims to help those preparing for giving evidence at an Inquiry as well as those involved in the management of the Inquiry. The event will feature a Mock Inquiry and will share some of the 'tricks of the trade'.

Development Management Update

Wednesday 21 September (venue tbc)

This event will provide an update on the development management issues currently facing the profession; it will look at good practice in development management, deliver a legal update and provide a commentary on practice and procedure. Recent case law and development management decisions will be examined.

Enforcement Update

Tuesday 8 November (venue tbc)

Planning Enforcement is an integral part of the planning service. Officers dealing with enforcement are at the front line of planning dealing daily with members of the public as well as elected members, as well as extensive planning knowledge they also have to be effective negotiators. This event will provide case law updates and practical examples to enable you to maintain and improve your skills.

Our historic environment plays a significant role in defining our built environment. This event will examine the challenges facing the heritage industry and consider how it and continue to positively shape the places we create.

Planning for Gear Change:

Planning for Active Travel

Tuesday 4 October (venue tbc)

In 2020, the Gear Change vision announced that, "England will be a great walking and cycling nation," and "Cycling and walking will be the natural first choice for many journeys with half of all journeys in towns and cities being cycled or walked by 2030."

With interventions like Low Traffic Neighbourhoods, CYCLOPS junctions, and Sparrow crossings becoming ever more commonplace, how are planners helping to fulfil this ambition?

Climate Risk and the Built Environment

Tuesday 7 June (venue tbc)

This event will consider what climate change impacts will mean for planning. It will look at how design will need to address issues around an aging population and what climate change adaptation looks like. It will consider what a net zero pathway could look like and how the circular economy will play a part in helping meet net zero carbon targets.

Future High Streets

COVID has accelerated high street trends and encouraged us to rethink our relationship with town and local centres. The government promotes levelling-up, and partnerships continue to deliver on the ground. This session brings together speakers from the public and private sectors covering socio-economic, design and delivery themes, case studies, local authority perspective and an interactive workshop.
