Minerals can only be worked where they lie. Planning across administrative boundaries is essential in making adequate provision for minerals to be supplied where and when they are consumed. However, the mechanisms available are generally weak and ineffective with supply routinely being assumed. For construction aggregates, the Managed Aggregates Supply System (MASS) provides measures for strategic planning for aggregates, but key components have suffered serious neglect in recent years. Speakers will provide an update of policy work at the Department of Levelling-up, Housing & Communities, and overview of measures and options to achieve better strategic planning and their relevance to minerals planning.

3.15 pm Marine aggregates, silica sand and dimension stone Mineral planning is about more than land-won aggregates of course. Supplies of marine-dredged aggregates are increasingly important, particularly in areas where land-won reserves and resources are becoming depleted or constrained and while subject to a separate planning and licensing regime, depend on adequate infrastructure for bringing ashore and distribution. Planning for industrial minerals such as silica sand, and for building stone involves specific considerations and an understanding of the different markets for materials. Speakers will provide perspectives from the different sectors and the planning issues that need to be addressed.
