The BGS is host to the UK Critical Minerals Intelligence Centre. In 2022, The UK Government launched its Critical Minerals Strategy in response to the global energy security concerns. The strategy, however, does not address other essential minerals also needed to enable the UK to achieve its net zero target. 2022 also saw the relaunch of the of the UK Minerals Strategy published by the Minerals Sector. Arguably, many of the broad concerns of mineral supply in the UK are similar for critical and non-critical minerals, and many of the actions to mitigate the concern are likewise similar. Planning reform is a perennial issue, and the speed and effectiveness of the system is usually cited by business and government as a barrier to growth. The Levelling Up and Regeneration Bill will introduce changes and the government has recently consulted on the scope of changes to the NPPF. As usual, most of this relates to housing, although there will be implications for minerals planning. Alex Minhinick will reflect on his experience using the Development Consent Order process to support NSIP developments and provide some thoughts on the potential for this alternative consenting route to be used for minerals.
