South Yorkshire praise from RTPI President

John Acres visited the Yorkshire region in September. During his two-day visit up North, the President visited the award-winning <u>Sheffield 'stuck sites' programme</u> as part of a walking tour of the city centre.

John praised the council's expertise and creativity in transforming these sites of regeneration and bringing them back into use.

The President also visited award winners Rotherham Council, who were named Local Authority Planning Team of the Year in the <u>2018 RTPI National Planning Awards</u> in May. John met the planning team and discussed a number of local projects and developments.

As part of his Yorkshire welcome, John also spoke to and answered questions from planning students at the University of Sheffield and attended a Heads of Planning meeting with Sheffield City Region.

Green Port Hull - Planning Excellence

Hull City Council won Yorkshire's top planning award for its vision and expertise in delivering Siemen's new offshore wind turbine blade manufacturing, assembly and serving facilities at the city's <u>Alexandra Port.</u>

The project is the centrepiece of the Green Port Hull vision to establish Hull and the East Riding of Yorkshire as a world class centre for renewable energy.

Calderdale Council were highly commended for the restoration of the <u>The Piece Hall</u>, a Grade I-listed, monumental building in Halifax town centre. It is the only surviving intact cloth hall in the UK and an iconic reminder of Halifax's once pivotal position at the centre of the world's woollen trade.

Continuing Professional Development

A continuing key role of RTPI Yorkshire is our high-profile, well-established <u>Yorkshire</u> <u>Conference Series.</u>

More than 750 delegates have attended our 10 conferences this year in Leeds, Sheffield and York.

The conferences, in partnership with Leeds Beckett and Sheffield Hallam University, have covered a range of topics including Affordable Housing, town centre regeneration, Development Management Law, and the Northern Powerhouse.

Overall feedback from attendees has been very positive, with particular highlights including our Development Management Practice and Annual Planning Law conferences.

Steve Quartermain, Chief Planner at the Ministry of Housing, Communities and Local Government (MHCLG) answered questions from more than 130 delegates in a lively session at our Development Management Practice event.

Affordable seminars

Informative seminars and a range of Young Planner events supporting the future generation of planners have continued to thrive in 2018.

Our <u>RTPI Yorkshire Practice Seminars</u> has continued – enabling planners to access highquality CPD at low prices. This year's events took place in Sheffield, Selby and Dewsbury.

Our <u>Young Planners</u> have had a busy year, continuing their excellent CPD and social events programme. Highlights include the *What makes a good place?* Seminar in Sheffield, the Annual Pub Quiz in Leeds, and the Christmas party in partnership with the Forum for the built environment. In 2019 we hope to encourage and expand activities by Young Planners in Yorkshire.

We will also continue our strong tradition in the region of awarding student prizes, Yorkshire Chair Richard Wood attended both Leeds Beckett and Sheffield Hallam award ceremonies this year to congratulate the winners in person.

Regional Research

Yorkshire has been at the forefront of RTPI research and policy in 2018, leading on its Great North Plan projects and continuing to ensure members views are communicated through liaison with the National <u>Policy and</u> <u>Research</u> team. These views have then been incorporated into RTPI's response to Government consultations on planning issues, such as the Transport for the North draft strategy consultation and roundtable discussions on the draft National Planning Policy Framework (NPPF).

RTPI Yorkshire is also well-represented nationally on the General Assembly, International and Membership and Ethics Committees and the Nations and Regions Panel.

Great North Plan

RTPI Yorkshire, North East and North West regions, in partnership with Peter Brett Associates and Newcastle University, have progressed a project called "<u>Ambitions for the North of England: People and Place".</u>

By promoting co-operation beyond traditional boundaries, it aims to create a joined-up

approach that would help Northern towns, cities and rural areas develop sustainably, ensuring that prosperity generated by the Northern Powerhouse is shared as widely as possible, not just in the key cities.

The RTPI and IPPR North launched a <u>Blueprint for a Great North Plan</u> in 2016 after consultation with over 400 Northern businesses and local leaders. The current project picks up this strand and complements the other ongoing Great North Plan collaborative strategies on transport, energy, natural assets, and the economy. The project's findings will be published in Spring of 2019 after a series of roundtable events.

International Yorkshire

Our International Network has continued to thrive. Highlight events include an evening presentation from Janet Askew, chair of the RTPI international Committee. Janet talked about the role of British planning globally at the *Planning and Partnerships* event in Leeds.

In the Spring, Clive Harridge, of the Commonwealth Association of Planners, gave a talk on how to tackle some of the biggest challenges to planners in the Commonwealth. "Our People and Place project will add much needed insight into people's needs and aspirations to inform big, vital decisions ahead."

Empowering Communities.

Supporting Planning Aid

RTPI Yorkshire works with <u>Planning Aid</u> <u>England</u> to advise on planning matters to a wide range of communities and helps recruit volunteers. There are currently 46 members in Yorkshire, including 23 chartered members. Planning Aid Yorkshire is led by a task group of volunteers supported by a member of staff based at RTPI national office. The task group plays a key role in identifying and developing outreach opportunities for Regional PAE volunteers to support, where outreach activity focuses in particular on communities in areas of deprivation and groups not traditionally engaged with planning.

Members of the task group regularly attend and present reports to meetings of the Regional Management Board and also take part in the monthly national PAE teleconference to exchange news on PAE activities across the country.

Neighbourhood Planning

More than 100 people attended this year's Neighbourhood Planning Forum in Leeds in

October. The event was held in conjunction with Leeds Beckett University, Leeds City Council, RTPI Yorkshire and Planning Aid England. Key speakers included Ian Mackay, Neighbourhood Planning Manager at Leeds City Council, and Tony Burton, Chair of the London Neighbourhood Planning Forum. A number of workshops and case studies, including the Holbeck Neighbourhood Forum, (commended at this year's Yorkshire Planning Excellence Awards) were presented.

After many years of good work, our aim in 2019 is to strengthen the Planning Aid Yorkshire core group with new members and raise the profile of Planning Aid Yorkshire.

Planning Aid Yorkshire will also work collaboratively with local planning authorities, as well as <u>Neighbourhood Planning</u> groups and community stakeholders.

As a result of this there are a number of exciting opportunities and volunteering roles in 2019 from local plan reviews to member training. If you are interested in volunteering on these projects please get in touch. Planning Aid Yorkshire provides planning advice and support to help individuals and communities and engage with the planning system and get involved in planning in their local area.
