 - 13 December 2024, the end of the calendar year finished on a sombre note with Tony Crooks funeral held at All Saint's Church in Curbar, near Grindleford. As President I attended alongside the Chief Executive and a number of Trustees. The funeral was well attended and an opportunity to say thank you to one of our Trustees who at the time of his death was Chair of the Education and Lifelong Learning Committee, Chair of the Governance Group and Vice Chair of the Audit and Risk Committee. Tony had also represented the Institute on many external bodies.

 13 January 2025, Local Government Association, 18 Smith Square Westminster Keynote speech to the new cohort of graduates starting LGA Pathways into Planning. Speaking alongside Anna Rose from PAS and David Waterhouse, MHCLG.

Interest in the scheme is high. Over2000 graduates applied for 2024/25 with around 700 making it through the assessment process. The programme offered 90 spaces, the scheme recruited 89 new planners into 59 local authorities. Applications are currently open for 25/26 and applications have already exceeded 1,700. LGA are aiming to offer 150 spaces minimum depends on council demand.

The scheme has also achieved 40% BAME representation, a 50/50 gender balance and just under 20% with social mobility indicators.
