Terms and conditions

Bookings and payments

- Payment for events must be paid in advance or your place may be given to someone else. You can pay using your credit or debit card or within 30 days of the date of the invoice we send you
- RTPI accepts no responsibility for non-attendance at booked events
- All prices are exclusive of VAT

Cancellations

- If you need to cancel your booking your cancellation must be received, in writing, at least 28 days before the event. If payment has been made a credit will be arranged. Please see below for the appropriate charge for this administrative service based on the cost of your booking:
 - o 28 days before the event: FREE
 - o 27 days or less before the event: 100% + VAT
- 27 days or less prior to the event, your place may not be cancelled (unless expressly authorised by the RTPI), but a substitute delegate can be named (see below)
- We reserve the right to charge an administration fee for cancellations to free events, as indicated on the event webpage.

Delegate Substitutions

- Substitute delegates can be named up to 5 working days before the event. However, if prior arrangement has been made with event organiser, substitutions may be made later than this. Please let us know as soon as possible if the substituted delegate has any dietary requirements or accessibility issues so we can try to accommodate them.
- For longer courses such as masterclasses which are focused on an individual's professional development and reflection on their own practice, it is not possible to make substitutions part the way during a course.

COVID Obligations

 By accepting these terms and conditions you are agreeing to adhere to our outlined Covid-19 safety protocols in place at the time of the event as indicated on our event webpage and to following any guidance requested by the venue.

Cancellations due to COVID

- If you need to cancel because you are isolating, or have COVID, we would ask that you notify us immediately. Where possible we will accept substitutions later as noted above.
- In the event where it is impossible to substitute the place, we will offer a credit or a refund on request. Regrettably, if the venue charges a cancellation fee, we may be unable to credit the event in full.

Data protection
